

BANKER'S ORDER NOTES

1. Enter the name and full address of your Bank or Building Society.
2. Enter the name of the account holder.
3. Enter the Sort Code, usually found in the top right-hand corner of your cheque (e.g. 44-55-66).
4. Enter the Account Number (usually found at the bottom of your cheque, on the right).
5. Enter the amount in figures and in words.
6. Enter the date of first payment, and choose monthly, quarterly or annually as appropriate.
7. Sign and date the form.
8. Leave number 8 for the Office to complete.

GIFT AID FAQs

Q Do I need to commit myself to a fixed period of time or a specific amount?

A No

Q How do I give?

A You can give by cheque or standing order. Cash can be given if it is in an envelope clearly marked with your name and the purpose of the gift (but don't send cash by post). You can also give by telephone or internet banking by arrangement.

Q What if I only pay a small amount of tax?

A Even if you only pay tax at the lowest rate (10%) we are still able to claim back 28%, but you need to let us know if you do not pay enough tax to cover the tax that we reclaim on your donations. If you are not sure, please ask us for help.

Q What if I stop paying tax?

A Just let us know, and we will stop claiming tax back.

Q What if I pay tax at the top rate (40%)?

A You can obtain extra tax relief by declaring the amounts on your tax return.
